- Lead financial planning cycles for portfolio under responsibility, with a strong focus on value, optionality, and opportunity cost, ensuring financial discipline while actively challenging assumptions and trade-offs across the portfolio.
- Proactively identify risks, opportunities, and inflection points across your portfolio responsibilities, incorporating market dynamics, competitive landscape, development uncertainties, and strategic options into recommendations.
- Deliver targeted analyses and insights on strategic topics (e.g., portfolio scenarios, resourcing trade-offs, external opportunities, or strategic shifts), in close collaboration with portfolio teams and finance stakeholders
