As a Demand Planning Manager, you will drive the tactical purchase planning process for all products to ensure the availability of finished goods and execution plan feasibility in accordance with Supply Chain inventory policy. Additionally, you will need to ensure effective supply forecasting and business planning. Also, you will be responsible for site data master processes, which aim to ensure accurate creation and maintenance of master data in company system in accordance with both local and global requirements.

- Inventory management - placing import orders based on the actual stock level and forecast with due consideration of SAP (accounting system) parameters, follow-up deliveries.
- Inventory optimization based on MOQ (month of Coverage), MOC (Minimal Order Quantity) and safety stock level ratio
- Forecast adjustments
- SAP master data maintenance
- Coordination and execution of product life cycles events including new launch, transfers, divestments, pruning and expirations
- Accountable for Sales and Business Planning documentation and reports maintenance.
- Preparation of reports for local management, RE and the departments.
- Channel Management - daily monitoring of customer forecasted accuracy.
- Monitoring of write-offs and conducting monthly review of stock overview reports.
