- Conduct targeted quality reviews and deep-dive assessments across NOCC processes, local controls, and higher-risk operational areas
- Leverage AI, FAN analytics, continuous monitoring, and digital tools to identify emerging risks, trends, control deficiencies, and anomalies
- Monitor remediation activities and control execution through NFCM Runbook, GRC Process Controls, and related governance platforms
- Partner with CFOs, FRA, FC&C, Internal Audit, control owners, and Global Assurance stakeholders to strengthen the control environment and drive accountability
- Translate complex risk findings into practical management actions and support agile assurance reviews across local, regional, and global priorities
